The John H. Clarke Fund

This fund was established in 1946 by John H. Clarke, a distinguished Youngstown citizen who became a Justice of the Supreme Court of the United States. Justice Clarke was a leading advocate of world peace; he was one of the organizers of this library, its second president and on his death became its chief benefactor. Income from this fund is devoted exclusively to the purchase of books.

The Myron S. Roh Library Fund

This fund was established through a bequest from Myron S. Roh in 2003. Mr. Roh served as a member of the Library's Board of Trustees for 22 years, from 1971 to 1993. Income from this fund's investments is to be used for the purchase of new books for the library system.

The Ruth Bowers Fund for Youth Programs and Services

Ruth Bowers was a teacher and principal in the Youngstown City School District for 29 years. Income and principal from the fund may be used by the library system for youth programming and services.

The Elizabeth Lowmiller Barnhill Fund

The Library Board of Trustees established the Elizabeth Lowmiller Barnhill Trust Fund in 1984. Interest proceeds from investments of the principal of this fund are to be used for the restricted purchase of children's books.

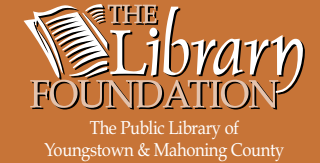
