MAHONING COUNTY HAS 225,786 RESIDENTS AND 89,527 ARE REGISTERED BORROWERS. FOR MANY RESIDENTS, THE PUBLIC LIBRARY IS THEIR ONLY SOURCE OF COMPUTERS, INTERNET, AND/OR WI-FI. THE LIBRARY PROVIDES A LARGE NUMBER OF LEARNING PROGRAMS, HOMEWORK SUPPORT, BUSINESS DEVELOPMENT AND WORKFORCE SUPPORT, AND REFERENCE WORK IN OUR BUILDINGS AND THROUGH OUR WEBSITE. THESE PROGRAMS SUPPORT OUR MISSION TO HELP OUR COMMUNITY TO GROW, TO SHARE, AND TO CREATE.
